Thank you for your show of support for the loving activity of Christian Science nursing, established in 1908 under the direction of Mary Baker Eddy in the bylaw, "Christian Science Nurse" in the Manual of The Mother Church. The ability to run Midland House, Inc and its activities is due to the contributions from Churches, Societies, and Individuals. Add to that the interest from investments and Midland received over **\$13,500** in income last fiscal year. After expenses the cash assets as of the fiscal year end were **\$267,957.98**.

Midland continues to be open to 1. financially assisting those seeking a career in Christian Science nursing by helping to fund tuition fees and 2. aiding fellow Christian Scientists in our coverage area with their nursing fees.

Donating IRA assets to charity. A benefit to non-itemizers.

Individuals 70½ and older may transfer up to \$100,000 from their IRA to Midland House, Inc. and receive the following benefits:

- Satisfy some or all of your required minimum distribution (RMD)
- Reduce your taxable income without relying on an income tax deduction
- Make an immediate gift to Midland

Among the guidelines to consider are these:

Qualifications	Distribution must be made to a qualifying charity; private foundations and donor-advised funds are not eligible. Consult a tax professional for additional information.
Direct contribution	The IRA Trustee or custodian must make the distribution directly to the charity. Distributions made payable to the IRA owner and transferred to the charity will not qualify.

It's important to consider your tax situation before deciding whether to make a charitable contribution from your IRA. Be sure to work closely with your financial representative to determine whether this tax provision is right for you.
